

AGREEMENT

KNOW ALL MEN BY THESE PRESENTS :

This Agreement made and executed this 10 day of October, 2017 at the City of San Fernando, by and between the DENR-Mines and Geosciences Bureau represented by Mr. Lope O. Cariño, Jr., OIC, Regional Director, with business address at Cleofer's Bldg., Gen. Hizon Avenue, City of San Fernando, Pampanga;

and

OTEL WALL STREET CORPORATION, a domestic corporation duly organized and existing under Philippine Laws with business address at Skype Plaza Bldg., Lazatin Blvd., City of San Fernando, Pampanga, represented by Ma. Rita Teresita S. Jingco, of legal age, married and Filipino herein referred to as the **SECOND PARTY**;

WHEREAS, the **FIRST PARTY** will conduct a Two Day Live In Seminar on October 10-11, 2017;

WHEREAS, the **SECOND PARTY** has agreed to provide Meals, use of Function Room for Two (2) days with One (1) night Hotel Accommodation the rate of One Thousand Eight Hundred Pesos (Php 1,800.00) per person for Thirty (30) participants with a **Total Contract Cost of One Hundred Eight Thousand Pesos (Php108,000.00)**;

WHEREAS, the **SECOND PARTY**, by way of this Agreement, accepts catering and accommodation of the participants during the activity;

WHEREAS, the **FIRST PARTY** has agreed to pay to the Second Party the total Contract Cost within Fifteen (15) days after the event. However, payment shall be based on the actual number of participants should the actual number of participants exceed the guaranteed number of participants;

In the instance the number of the participants exceeds the accommodation capacity of the **SECOND PARTY**, the **FIRST PARTY** hereby allows the **SECOND PARTY** to accommodate them at the latter's affiliates /hotel partners with the same rate;


WHEREAS, non compliance of any of the parties shall render this Agreement null and void;
