**RESOLUTION No. 13, Series of 2017**

**Resolution Recommending the Issuance of the Notice of Award For the  
Construction of Mines and Geosciences Bureau Regional Office III Building  
(Phase-II Structural Works)  
To BUILDERS EXPONENT ENTERPRISE**

**WHEREAS**, the Mines and Geosciences Bureau Regional Office No. III (MGB-RIII), through the General Appropriations Act for FY 2017 intends to apply the sum of **NINE MILLION NINE HUNDRED FIFTY THOUSAND PESOS ONLY (PhP9,950,000.00)** being the Approved Budget (ABC) of the Contract for the **Construction of MGB Regional Office III Building ( Phase - II Structural Works)** located at the Diosdado Macapagal Government Center, Barangay Maimpis, City of San Fernando, Pampanga;

**WHEREAS**, On June 15, 2017 and for a period of seven (7) days thereafter, the MGB-RIII, thru its Bids and Awards Committee (BAC), posted the Invitation to Bid for Public Bidding, the **Construction of the Mines and Geosciences Regional Office No. III Building (Phase-II Structural Works)** in the PhilGEPS, MGB-RIII Bulletin Board, MGB-RIII website and other conspicuous place at the premises of the Office of MGB RIII located at 2F Cleofer's Building, Gen. Hizon Ave., City of San Fernando, Pampanga;

**WHEREAS**, in response to the said posting, three (3) bidders, namely: N.T. Tulabot Construction J.Q.M. Construction & Trading, and Builders Exponent Enterprise submitted their Bids within the set period;

**WHEREAS**, during the Opening of Bids held on July 13, 2017, N.T. Tulabot Construction was disqualified as its bid documents lacked the following requirements:

1. The Bid Documents has no Table of Contents and pagination I;
2. There was no documentary stamp affixed in the Bid Securing Declaration;
3. There was no Certificate on Safety and Health duly issued by Philippine Red Cross to the designated safety engineer;
4. There was no attached list of laboratory apparatus accredited by DPWH;
5. There was no Constructor's Performance Evaluation System (CPES); and
6. There was no Single Largest Contract Completed (SLLC) presented

**WHEREAS**, the qualified bidders have the following amounts of bids:

**WHEREAS**, N.T. Tulabot did not file any motion for reconsideration on its disqualification within the prescribed period of three (3) days upon written/ verbal notification pursuant to Section 55 (Protest on Decision of the BAC) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 otherwise known as the Government Procurement Reform Act;


**WHEREAS**, the bid of Builders Exponent Enterprise is considered as the Lowest Calculated Bid;

**WHEREAS**, the BAC conducted a post-qualification on July 25 and 28, 2017 and found that Builders Exponent Enterprise complied with and was responsive to all the requirements and conditions as specified in the Bidding Documents;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, do hereby **RESOLVED** as it is hereby **RESOLVED**, to recommend to the Regional Director of this Office, the issuance of the Notice of Award in favor of **Builders Exponent Enterprise** with office address at Arellano Avenue, Mulawin, National Road, Orani, Bataan, as the winning bidder for the *Construction of the Mines and Geosciences Regional Office No. III Building (Phase-II Structural Works)*;


