WHEREAS, the Mines and Geosciences Bureau Region III (MGB-RIII) will be conducting an IEC Culminating Activity (Geohazard Summit) on August 15-18, 2017, in the Province of Tarlac;

WHEREAS, on August 01, 2017, the Bids and Awards Committee (BAC) posted in the MGB website and Bids and Awards Bulletin Board, the Request for Quotation (RFQ) for the Service of Hotel, Lodging and Meeting Facilities under P.R. No. 2017-118, with a Contract Price of **Eight Hundred Fifty Thousand Pesos (PhP 850,000.00)**;


WHEREAS, after due deliberation, the MGB-RIII BAC found the proposal of Dampa Sa Tarlac as the lowest calculated and responsive bid;




