**Resolution Recommending the
Award of Contract For Lease of Venue, Meals and Accommodation**

WHEREAS, the Mines and Geosciences Bureau (MGB) Region III has approved Purchase Request No.2017-195 dated October 30, 2017 for "**Lease of Venue, Meals and Accommodation**" for the conduct of Geohazard Summit in Zambales, on November 15-17, 2017, with a Contract Price of **Seven Hundred Thousand Pesos (PhP 700,000.00)** only.

WHEREAS, on the same date, the BAC also sent invitation letters to three (3) prospective suppliers/bidders namely, Isla De Potipot Hotel and Beach Resort, The Gateway Resort and Dawal Resort to submit quotations for the November 15-16, 2017 scheduled seminar;

WHEREAS, the submitted quotations of above said suppliers are follows:



- b) Mansion Garden Hotel as responsive bid for the November 17, 2017 scheduled seminar


