WHEREAS, the Mines and Geosciences Bureau Region III (MGB-RIII) has approved **Purchase Request No. 2017-104** dated July 10, 2017 for the supply of communication equipment ( Five (5) units of laptops), with a Contract Price of **Two Hundred Fifty Thousand Pesos (PhP 250,000.00)**;

**WHEREAS**, the MGB-RIII BAC Technical Working Group decided that procuring two (2) laptop brands could be an advantage and reference for further procurements;




