#### **Resolution Recommending the Award of Contract For Lease of Venue, Meals and Accommodation To PLAZA HOTEL**

**WHEREAS**, the Mines and Geosciences Bureau (MGB) Region III has approved Purchase Request No.2017-184 dated October 13, 2017 for "**Lease of Venue, Meals and Accommodation**" for the conduct of Geohazard Summit in Bataan, with a Contract Price of **Four Hundred Thousand Pesos (PhP 400,000.00)** only.

**WHEREAS**, on the same date, the BAC also sent invitation letters to three (3) prospective suppliers/bidders namely, **PAN RESORT & EVENT PLACE** , **CROWN ROYALE HOTEL & RESORT CORP.** to submit quotations for the said seminar ;

**WHEREAS**, the proposals/quotations of the above-stated hotels and training establishments are as follows:


**WHEREAS**, after due deliberation, the MGB-RIII BAC found the proposal of Plaza Hotel as the lowest calculated and responsive bid;
