**Resolution Recommending the Award of
Purchase of Linoleum**

WHEREAS, the Mines and Geosciences Bureau Regional Office No. III (MGB-RIII) approved Purchase Request No. **2017-070** dated May 26, 2017 for the Award of Purchase of Linoleum amounting to **Ninety Two Thousand Eight Hundred Pesos (PhP 92,800.00)**;
