**Resolution Recommending the Award of
Supply of T-Shirts with Print**

WHEREAS, the Mines and Geosciences Bureau Regional Office No. III (MGB-RIII) approved Purchase Request No. **2017-101** dated July 05, 2017 for the Award of Supply of T-Shirts with Print amounting to **Three Hundred Ninety Thousand Pesos (PhP 390,000.00)**;

WHEREAS, on July 7, 2017, the MGB-RIII through its Bids and Awards Committee (BAC), posted in the Phil-Government Electronic Procurement System (PhilGEPS), MGB R-III website and in the MGB R-III Bulletin Board, the Request for Quotation (RFQ) of the said item/s using the Alternative Mode of Procurement "Negotiated Procurement – Small Value Procurement," under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act;

WHEREAS, in response with the said advertisement, six (6) bidders namely: Tanjer Enterprises, Ceboom Enterprises, JC Digiprints & GrafX, Knit & Tuck Merchandising and Zashen Fashions submitted their proposals within the set period. Also, Zhujar Manufacturing Inc. submitted its bid but after the prescribed deadline;

WHEREAS, the submitted quotations of the six (6) bidders are reflected as follows:



WHEREAS, after inspection of the sample printed t-shirts of Tanjer Enterprises being the second lowest price offer, the same was found to meet the requirement for such printed shirt.


