**WHEREAS**, the Mines and Geosciences Bureau Region III (MGB\_RIII) has approved Purchase Request No. **2017-123** dated August 1, 2017 for the Supply of Customized Folding Umbrellas with print (3,764 pcs-assorted colors), amounting to **Three Hundred Seventy Six Thousand Four Hundred Pesos (PhP 376,400.00)**;
