WHEREAS, in response with the said advertisement, two (2) bidders namely: – Manabat Trading Corporation & Fleet SERV submitted their proposals within the set period;

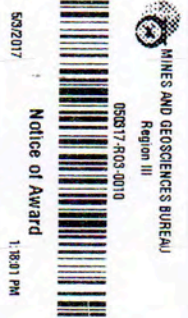
WHEREAS, on April 25, 2017, the BAC made a second posting and out of the three (3) sent letters invitation to bid only two (2) submitted their proposals;

WHEREAS, the BAC was later informed by the representative of Pampanga CATL Trading Inc. that one of the item needed is out of stock;


