**WHEREAS**, the Mines and Geosciences Bureau (MGB) Region III has approved Purchase Request No.2017-109 dated July 24, 2017 for the **Supply and Installation of Vertical PVC Blinds** (27 pcs. -1,282.94 sq .ft., corrugated curve , green color), amounting to **One Hundred Twenty Five Thousand Pesos (PhP 125,000.00)**;




