Failure of Bidding

WHEREAS, the Mines and Geosciences Bureau Regional Office No. III (MGB-RIII) approved Purchase Request No. **2020-07-066** dated July 01, 2020 for the Award for Construction Project amounting to **Sixty Six Thousand Pesos (PhP 66,000.00)**;

WHEREAS, the MGB R-III, through its Bids and Awards Committee (BAC), posted on August 13, 2020 in the Phil-GEPS and Bids and Awards Bulletin Board, the Request for Quotation (RFQ) of the said item/s using the Alternative Mode of Procurement "**Negotiated Procurement-Small Value Procurement**" under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184;

WHEREAS, on August 14, 2020, the BAC also sent Request for Quotation to three (3) prospective suppliers namely, Ma-An Construction Corporation, Evan Tiangco Fabricator and Lumboy Iron works.;

WHEREAS, the submitted quotations are reflected as follows:

WHEREAS, upon further verification, Lumboy Iron works though having the lowest bid was found to be a non PhilGeps member, same with Evan Tiangco Fabricator;

WHEREAS, though Garlex Enterprises is PhilGeps registered, the Proprietor failed to present a concrete lay out for the said construction upon conducting a meeting. Likewise, the Committee (BAC) was informed that it would take him twenty-five (25) days to finish said project which the Committee found to be too long.

NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **FAILURE OF BIDDING** for the Award for Construction Project.
