WHEREAS, the Mines and Geosciences Bureau Regional Office No. III (MGB-RIII) approved Purchase Request No. **2020-11-151** dated November 03, 2020 for the Award of Purchase of Information Technology Parts & Accessories Peripherals amounting to **Seven Hundred Ninety Five Thousand Pesos (PhP 795,000.00)**;

WHEREAS, the end-user requested to the BAC Committee that the remaining items listed which were not quoted be posted again. The Committee agreed and approved said request;


