Resolution Recommending the Award of Purchase of Office Supplies and Devices

WHEREAS, the Mines and Geosciences Bureau Regional Office No. III (MGB-RIII) approved Purchase Request No. **2020-10-138** dated October 19, 2020 for the Award of Purchase of Office Supplies and Devices amounting to **Three Hundred Thirty Thousand Pesos (PhP 330,000.00)**;

WHEREAS, the MGB R-III, through its Bids and Awards Committee (BAC), posted on October 25, 2020 in the Phil-GEPS and Bids and Awards Bulletin Board, the Request for Quotation (RFQ) of the said item/s using the Alternative Mode of Procurement "**Negotiated Procurement-Small Value Procurement**" under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184;

WHEREAS, on October 26, 2020, the BAC sent Request for Quotation to five (5) prospective suppliers namely, Orchid's Book Store, Good Luck Bazar, Pandayan Bookshop, CRED General Trading and KNF Enterprises but seven (7) suppliers submitted their quotations that include Ban Bee Commercial Co. Inc. and PBT Technology Solutions Inc. ;

WHEREAS, on November 3, 2020, the BAC Committee convened together with the end-user and discussed the items to be purchased based on the specifications and qualifications set-forth by the end-user;

WHEREAS, as agreed after the meeting, the following items to be purchased are reflected as follows:


