**WHEREAS**, the Mines and Geosciences Bureau Region III (MGB-RIII) has approved Purchase Request No. 2019-07-094 dated July 29, 2019 for the **Garments**, with a Contract Price of **Seventy Eight Thousand Seven Hundred Fifty Pesos (PhP 78,750.00)** only;

**WHEREAS**, the MGB-RIII, through its Bids and Awards Committee (BAC) posted on July 30, 2019 in the PhilGEPs, MGB-RIII website and Bids and Awards Bulletin Board, the Request for Quotation (RFQ) of the said item/s using the Negotiated Mode of Procurement under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184;

**WHEREAS**, on July 30, 2019, the BAC also sent Request for Quotation to three (3) prospective suppliers namely, Powerscan Computer Systems & General Merchandise, Simbillo ADS and Beehive Advertising;

**WHEREAS**, in response with the sent RFQ, only one (1) bidder/supplier, submitted its quotation which is as follows:

**WHEREAS**, upon careful examination of the submitted quotation, the item does not conform with the prescribed material for the said T-shirt;

**WHEREAS**, the BAC agreed to make another posting with an increased contract price amounting to **One Hundred Twenty Three Thousand Seven Hundred Fifty Pesos (PhP 123,750.00)**;

**NOW, THEREFORE**, We the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to declare **FAILURE OF BIDDING** for the Procurement of Garments.
