### RESOLUTION NO. 19 Series of 2019

#### Resolution Recommending the Award of Procurement of Security Services (2 shifts x 12 hrs./shift)

**WHEREAS**, the Mines and Geosciences Bureau Regional Office No. III (MGB-RIII) approved Purchase Request No. **2019-10-131** dated October 29, 2019 for the **Award of Procurement of Security Services for CY 2020 ( 2 personnel – 2 shifts x 12 hrs./shift )** amounting to **Six Hundred Fifty Thousand Pesos (PhP 650,000.00)**;

**WHEREAS**, the MGB through its Bids and Awards Committee (BAC), made a 2<sup>nd</sup> posting in the Phil-GEPS and MGB R-III Bulletin Board on November 18, 2019, the Request for Quotation (RFQ) of the said item/s using the Alternative Mode of Procurement "Negotiated Procurement – Small Value Procurement," under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act;

**WHEREAS**, on November 18, 2018 the BAC also sent Request for Quotation to three (3) prospective agencies namely, Tiger 2010 Security Agency Inc., Bantayan Security Agency, Inc. and Best Guards Security Services Phils. Inc.;

**WHEREAS**, the BAC received only two (2) submitted quotations of the bidders out of three (3) sent RFQ which are reflected as follows:
