Resolution Recommending the Award of
Purchase of Information Technology Parts & Accessories Peripherals

WHEREAS, the Mines and Geosciences Bureau Region III (MGB-RIII) has approved Agency Procurement Request No. 2019-03-029 dated March 12, 2019 for the **Purchase of Information Technology Parts & Accessories Peripherals**, with a Contract Price of **One Hundred Seventy Five Thousand Pesos (PhP 175,000.00)** only;

WHEREAS, the MGB-RIII, through its Bids and Awards Committee (BAC) posted on March 22, 2019 in the PhilGEPS, MGB-RIII website and Bids and Awards Bulletin Board, the Request for Quotation (RFQ) of the said item/s using Negotiated Procurement – Small Value Procurement as the Mode of Procurement under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184;

WHEREAS, on March 22, 2019 the BAC also sent Request for Quotation to five (5) prospective suppliers namely, Silicon Valley, CRED General Trading, CJ Lhantz and Computer Center, The Value Systems Phils. Inc. and BITMAP Marketing, Com. Inc.;

WHEREAS, in response with the said advertisement, five (5) bidders/suppliers, submitted their quotations namely: CJ Lhantz Trading & Computer Center, BITMAP Marketing Com. Inc., Silicon Valley, The Value Systems Phils. Inc. and CRED General Trading;

WHEREAS, as evaluated per attached Abstract of Quotations, none among suppliers has offered lowest bid for each and all of needed items but each of four (4) among them have its own lowest bid on some items only;




