Resolution Recommending the Award of Purchase of Information Technology Parts & Accessories Peripherals

WHEREAS, the Mines and Geosciences Bureau Region III (MGB-RIII) has approved Procurement Request No. 2019-11-140A dated Nov. 12, 2019 for the **Purchase of Information Technology Parts & Accessories Peripherals**, with a Contract Price of **Nine Hundred Two Thousand Pesos (PhP 902,000.00)** only;

WHEREAS, the MGB-RIII, through its Bids and Awards Committee (BAC) posted on November 14, 2019 in the PhilGEPS, MGB-RIII website and Bids and Awards Bulletin Board, the Request for Quotation (RFQ) of the said item/s using Negotiated Procurement – Small Value Procurement as the Mode of Procurement under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184;

WHEREAS, on November 14, 2019 the BAC also sent Request for Quotation to five (5) prospective suppliers namely, Silicon Valley, Tri-Ace Enterprises, PCWORX, PC Express and Enigma Technologies;

WHEREAS, in response with the said advertisement, four (4) bidders/suppliers, submitted their quotations namely: CJ Lhantz Trading & Computer Center, Silicon Valley, The Value Systems Phils. Inc. and Tri-Ace Enterprises;

WHEREAS, after due deliberation, the MGB R-III BAC found the proposal of Tri-Ace Enterprises as the preferred supplier since items offered has met the requirements of the end-user;
