Resolution Recommending the Award of Rental of Vehicle

WHEREAS, the Mines and Geosciences Bureau Region III (MGB R-III) has approved Purchase Request No. **2019-01-008** dated January 25, 2019 for “**Rental of one (1) Unit Second Hand Vehicle**” with a Contract Price of **Three Hundred Eighteen Thousand Pesos (PhP 318,000.00)** only ;

WHEREAS, the MGB R-III, through its Bids and Awards Committee (BAC), posted on January 29, 2019 in the Phil-GEPS, MGB-RIII website and Bids and Awards Bulletin Board , the Request for Quotation (RFQ) of the said item/s using the Alternative Mode of Procurement “**Negotiated Procurement-Small Value Procurement**” under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184;

WHEREAS, on January 29, 2019 the BAC also sent Request for Quotation to four (4) prospective suppliers namely, Alpha Venice Tours and Travel, Rent Express Car Rental, Jacob Gutierrez Transport Service and R.M. Dialogo Car Rental;

WHEREAS, in response with the request for quotation and posting, hereunder are the prices quoted by interested bidders/suppliers:


- (1) Proximity – R.M. Dialogo Car Rental is within the Province of Pampanga while Renztyrde Transport is from the Cordillera Administrative Region;
